Important Notice- Haveli Farmstay Policy & Rules

- 100 % advance Payment deposit at the time of Check in.
- GST / Taxes charged extra and applicable as per government directives.
- We do not accept personal Cheques for payment.
- It is Mandatory for all customers and their visitor guests to share their ID cards (Adhaar/DL). Foreign Nationals are required to present their passport and valid visa.
- Gambling, Prostitution, contraband goods, drugs, etc – are all strictly prohibited within our premises.
- Haveli Farm stay/Management/Owner will not be responsible for any accidents/incidents occur due to Slips, Trips, Falls, Fire Hazards, Structural Failures, Natural Disasters, animal attacks/bites, Theft and Burglary, Violence and Harassment, swimming Pool and Water Safety & Health Emergencies
- Amendment / changes of bookings is allowed until only 72 hours (3 days) prior to arrival. Request will be considered as per availability.
- The Management will not in any way whatsoever be responsible for any loss / or damage to the Guest's belongings for any cause whatsoever.
- The Guest shall be solely liable and responsible to the management, its other customers guests, invitees visitors, agents and servants for all financial loss or otherwise and damage that may be caused as a result of the guests' own negligence and non-observance of any Haveli Farmstay rules policy or instructions
- The Management has the right to request any guest to vacate his/her room or other areas of the Haveli Farmstay forthwith, Without previous notice and without assigning any reason whatsoever, and the guest shall be bound to vacate when requested to do so. In case of the default, the Management has the right to remove the Guest luggage and belongings from the room occupied by him/her
- Guest are requested to observe, abide by confirming to and be bound by all applicable acts and laws and Government rules and regulations in force from time to time.
- Due to the fact that the Haveli Farmstay is located in a residential area it is required that guests, particularly those in groups are respective in regards to noise during the night.
- Guest are not allowed to make big noise outside cottage/building which can cause disturbance to our neighbours after 9 pm
- Please note that the check-in and key-collection take place at the Haveli Farmstay from caretaker.
- For any Damage done to the Haveli Farmstay amenities, articles, furniture, property., etc., by or due to guests themselves or their visitor or any other person for whom they are responsible, guests will be held responsible and so must make up to pay and settle for such loss and damage in full as deemed appropriate by the management.
- The Haveli Farmstay may deny further accommodation to a guest who does not prove to be decent and comply with the Haveli Farmstay policy and rules.
- It is not allowed to cause any disturbance to other guests nor cause any nuisance or annoyance in the Haveli Farmstay premises. It is agreeably anticipated that guest will conduct themselves in a respectable, civilized, and decent manner.
- Guests are requested to observe, abide by confirming to and be bound by all applicable acts and laws and Government rules and regulations in force from time to time.
- THE Haveli Management reserves the right to ADD or ALTER or AMMEND any of the above policy at any point of time without prior notice.
